What You Do

ISO 45001 System Implementation & Maintenance

- Support the continued development and implementation of an ISO 45001-compliant Health and Safety Management System.
- Maintain documentation, procedures, and records to meet certification requirements.
- Assist in internal audits and coordinate external audits with certification bodies.
- Coordinate the annual management system review with Senior Leaders and Board members.

Risk Management

- Conduct risk assessments across national and regional sporting events, facilities, and operations.
- Develop and implement control measures to mitigate identified risks.
- Monitor and review risk registers and ensure alignment with organisational risk appetite.
- Ensures all hazards are promptly assessed for their significance and managed.

Incident Management & Investigation

- Lead or support investigations into incidents, near misses, and injuries.
- Ensure timely reporting and root cause analysis.
- Recommend corrective actions and track implementation.
- Work with Super Clubs, Unions, and Teams in Black on injury prevention strategies.



Training & Capability Building

- Deliver health and safety inductions and training for staff, volunteers, and contractors.
- Ensure all Super Clubs undertake compliant induction sessions for contracted players and staff.
- Develop resources and toolkits for regional sub-units to build local capability.
- Promote a proactive safety culture through education and engagement.
- Actively encourage employee and player participation in health and safety.

Compliance & Legislative Monitoring

- Ensure compliance with relevant health and safety legislation across all jurisdictions.
- Monitor changes in legislation and standards and update policies accordingly.
- Liaise with regulatory bodies as required.
- Maintain Health & Safety policy in line with 'best practice'

Support for Super Clubs and Provincial Unions

- Provide guidance and support to regional health and safety representatives.
- Facilitate regular communication and knowledge sharing across these locations and teams.
- Coordinate national safety campaigns and initiatives with local implementation.

Reporting & Continuous Improvement

- Prepare regular health and safety performance reports.
- Analyse trends and recommend improvements.
- Support the development of strategic health and safety objectives.
- Monitor health and safety actions across all franchises on a monthly basis to ensure continued compliance and opportunities for improvement
